HIVPC Committee Descriptions						

HIV Health Services Planning Council (HIVPC) - Monitors, evaluates, and continuously improves systematically the quality and appropriateness of HIV care and ser- vices provided to all patients receiving Part A and MAI-funded services.

Executive Committee - Sets agenda for Council meetings, addresses conflict of interest issues, reviews attendance reports, oversees the planning activities established in the Comprehensive Plan, oversees committee work plans, reviews committee recommendations, ratifies recommendations for removal for cause, and addresses unresolved grievance issues.

Priority Setting Resource Allocation (PSRA) Committee - Recommends priorities and allocation of Ryan White Part A funds. Facilitates the Priority Setting and Resource Allocation Process to include the review of appropriate data (service utilization, epidemiological data). Develops, reviews, and monitors eligibility, service definitions, as well as language on 'how best to meet the need.

Quality Management Committee (QMC) - Ensures highest quality HIV medical care and support services for PLWHA by developing client and system-based outcomes and indicators. Provides oversight of standards of care, develops scopes of service for program evaluation studies, assesses client satisfaction, and provides QM staff/client training/education.

Membership/Council Development Committee (MCDC) - Recruits and screens applications based on objective criteria for appointment to the Council in order to ensure demographic requirements of the Council are maintained according to the Ryan White Treatment and Modernization Act. Presents recommendations to the Council. Institutes orientation and training programs for new and incumbent members.

Community Empowerment Committee (CEC) - Encourages the participation of individuals infected and affected with HIV/AIDS in the planning, priority-setting and resource-allocation processes. Function as a primary level of appeal for unresolved grievances relative to the Council's decisions regarding Ryan White Part A funding.

System of Care (SOC) Committee - Evaluates the system of care and analyzes the impact of local, state, and federal policy and legislative issues impacting PLWHA in the Broward County EMA. Plans and addresses coordinated care across diverse groups by engaging community resources to eliminate disparities in access to services.



## Medical Nutrition Therapy and Emergency Financial Assistance RFP Updates

 Medical Nutrition Therapy (MNT) and Emergency Financial Assistance (EFA) Applications are currently being reviewed as part of the RFP submission process

## Ryan White Part A Service Delivery Model Updates

- Medical Case Management (MCM), Non-Medical Case Management (NMCM), and Food Services SDMs are currently being reviewed to be presented at the upcoming System of Care meeting on November 2, 2023.
- Legal, Substance Abuse, Mental Health, & Universal have started the beginning stages of review.
- As this is the first time we have had to review the SDMs for an RFP since 2017, we are having to review all SDMs.

## Service Deliver Model Next Steps

- CIED and HICP have also begun to be reviewed, However due to the scope of revisions, these will take additional time.
- Ambulatory will be reviewed after Legal, SA, MH, & Universal



HIV Prevention staff served 170 individuals with condoms, PrEP education, incentives, and pamphlets.
- On 7/31/23, The HIV Prevention team organized and led three PrEP Outreach Events: one on Sistrunk, one at the downtown Fort Lauderdale bus terminal, and one at Sistrunk Four corners, serving 15, 40, and 14 people respectively. The team educated the community on resources that are offered and the importance of getting tested, and distributed condoms, lubricant, Get PrEP materials, and blankets.
- On 8/5/23, DOH Broward HIV Prevention staff set up a table at the Health and Education Love Project (HELP) Fair at Christ Apostolic Church, alongside other organizations including Mental Health Management, Law Enforcement, and Miami Dade College. Prevention staff spoke with 60 individuals to increase awareness of HIV prevention activities, including PrEP. They invited HIV department to come up to talk briefly about the services that we offer, and provided condoms, PrEP education, and promotional items.
- On 8/5/23, the Markham Health Back to School took place at Markham Elementary in Pompano Beach, Florida. The event featured multiple tables with resources for preventative care as well as educational information. At the event, the Florida Department of Health in Broward County provided tabling to increase awareness of HIV prevention activities which included: resources to access PrEP to reduce the risk of

acquiring HIV, condoms (both male/female) for safer sex practices, and educational pamphlets on who should get tested and when. A total of 220 individuals were documented to have stopped by the table with ages ranging from 13-60+ years old.

- On 8/12/23, HIV Prevention staff attended Pride Fete, an outdoor event taking place in Wilton Manors, FL on the walkway of the Richardson Historic Park grounds. The event featured multiple tables with resources for preventative care as well as educational information. At the event, The Florida Department of Health in Broward County provided tabling to increase awareness of HIV prevention activities, including PrEP. A total of 210 individuals were served with condoms, PrEP education, and marketing materials. 30 individuals scanned the QR code to get an at-home test.
- On 8/18/23, HIV Prevention staff attended Summer Jamz at Mills Pond Park. The event featured live entertainment by artist Silk and Shai and a local band, food trucks, vendors, and music. The event also featured a kid's zone with bounce houses and yard games for entertainment. At the event, the Florida Department of Health provided tabling to increase awareness of HIV prevention activities, including PrEP. A total of 190 individuals was provided condoms, PrEP educational materials and incentives.
- On 8/19/23, HIV Prevention staff set up a table at Back to School & Family Fun Day, a familyfriendly event taking place in Hollywood, FL at the community center at Washington Park. The event featured multiple tables with resources for families as well as groceries and school supplies for those who were pre-registered for the event. Students were able to get free haircuts and snacks while parents talked to the vendors. At the event, The Florida Department of Health in Broward County provided tabling to increase awareness of HIV prevention activities, including PrEP. A total of 118 individuals stopped by the table and were provided condoms, PrEP education, and marketing materials. 15 individuals scanned the QR code to get an at-home test.
- On 8/24/23, DOH Broward HIV Prevention staff attended the Boomers & Senior Expo Health Fair. There were several tables during the event featuring vendors and senior resources. A total of 87 people received HIV prevention education and materials.
- On 8/24/23, DOH Broward attended Sisters in Health Unity at ArtServe in Fort Lauderdale. Transinclusive Group and other community partners hosted an impactful community town hall. Focused on centering the health of Black women and women of color, this event featured an engaging panel discussion, entertainment, food & refreshments, and opportunities to connect with other community organizations. This event was dedicated to promoting awareness, empowerment, and unity in women's sexual health. With a specific focus on Black women and women of color, join us as we come together to address essential topics and foster a supportive community where all women and femmes of transgender and cisgender experience can thrive. There were upwards of 60 Individuals in attendance.
- On 9/9/23, Women Impacting Neighborhoods, Inc., partnered alongside United Way of Broward County to host a Suicide Kickball Day of Hope in Miramar. The purpose of this event is to bring awareness to preventable suicide strategies and other resources available to individuals within the Broward County Area. The Department of Health in Broward County tabled at event and was able to educate the community of HIV prevention and awareness. There was a fun day of Kickball, many different vendors participated. There was a live DJ and bounce houses and face painting for the kids. A total of 60 individuals were provided with condoms, PrEP education, and incentives.

- On 9/13/23, Broward College Safety Day was held at the Coconut Creek campus. Students were introduced to community resources including applications for various assistance programs, interactive games, enticing incentives, and a live demonstration by the Broward County K-9 unit. DOH Broward hosted a booth to enhance awareness about the HIV epidemic in Broward County. The outreach team engaged individuals in discussions about prevention methods such as PrEP, shared essential facts about HIV, stressed the significance of regular testing, and even conducted a simulated demonstration on proper condom usage. 83 individuals benefited from this event, receiving incentives, valuable PrEP education, and access to condoms.
- On 9/19/23 Broward College Safety Day was held at the Davie campus in partnership with local law enforcement and community agencies. DOH Broward staff provided tabling to increase awareness of HIV prevention activities, including PrEP. A total of 106 individuals stopped by the table and were provided condoms, PrEP education, and marketing materials. A total of 13 individuals scanned the QR code to get an at-home HIV test.
- On 9/15/23, DOH Broward HIV Prevention staff attended Carter Park Jamz a local family-friendly event taking place in the priority area of Broward County. The event features: food trucks, vendors, music, and live entertainment, At the event, The Florida Department of Health in Broward County provided tabling to increase awareness of HIV prevention activities, including PrEP. A total of 318 individuals were provided with condoms, PrEP education, and marketing materials.
- On 9/23/23, Faith Tabernacle organized a free health fair event for the community to attend and learn about the various resources the area has to offer, which included free on-site health screenings and HIV testing. During the event the Department of Health in Broward County provided tabling to increase awareness of HIV prevention activities, including PrEP. A total of 70 individuals were provided with condoms, PrEP education, and incentives.
- On 9/30/23, Nova Southeastern University hosted the Mission United Helping Hands Veteran Stand Down event at their Don Taft Center to offer various resources to veterans and the community. Some of the resources included housing assistance, health insurance, job assistance, and health promotion. During the event, the Department of Health in Broward County provided tabling to increase awareness of HIV prevention strategies; including PrEP, safer sex practices, and resources on how to get tested for various STIs. A total of 70 individuals were provided with condoms, PrEP education, and marketing materials.

#### Perinatal Program

In 2023 to date, the Perinatal Prevention program in Broward County:

- Received 64 HIV-positive pregnant women to case manage and ensure they are taking meds and receiving prenatal care. Forty-eight babies have been born to HIV-positive women, all of whom have had at least one negative PCR to date.
- Held 9 HIV Providers Network meetings.
- Hosted the 22nd Biannual Perinatal HIV Symposium in conjunction with the South Florida AIDS Education and Training Center. It was held virtually and in person, with 115 attendees.
- There have been 14 congenital syphilis cases.
- Perinatal program staff participated in 11 grand rounds to hospitals and OB/GYNs.
- Perinatal program staff have participated in 6 Haitian Radio PODS regarding HIV.
- The Perinatal program took part in 5 community Baby Showers to educate on Perinatal HIV transmission and provide gifts to the pregnant women.

- The Rapid PrEP Program is steadily growing for client intakes and follow-ups. Among the 713 clients that completed a PrEP Intake during this quarter 86 % represented Broward County Priroity Pouplations for Primary HIV Prevention.
- Community Outreach opportunities is constantly increasing. More nontraditional partners have been open to traditional collaboration and in person trainings. This has allowed us to conduct 17 Community outreach events during this quarter and 52 trainings in the community. DOH Broward staff has also recertified with BSO to continue providing HIV 101 educational sessions in the county jail.
- Attendance at the Broward County HIV Prevention Planning Council Meetings & advisory group meetings are increasing.
