Starting November 1, 2024, you can enroll, re-enroll, or change your health plan through

the Health Insurance Marketplace for coverage in 2025. Now is the perfect time to plan for your 2025 health coverage. The Open Enrollment Period runs from November 1, 2024, to January 15, 2025, but enrolling by December 15, 2024, guarantees your coverage will begin on January 1, 2025. To learn how to save on Marketplace premiums or see if you qualify for financial assistance, visit www.healthcare.gov or call the Marketplace Call Center at 1-800-318-2596. TTY users can call 1-955-889-4325. For one-on-one assistance from a BRHPC Get Covered Broward Program representative, call 1-800-794-2208. Our team members can help residents enroll in affordable health insurance plans in English, Spanish, and Haitian Creole.

BRHPC is awaiting the Chancery Court's final decision on the Insurance Assistance Benefits Program award through the State of Tennessee AIDS Drug Assistance Program (ADAP). The decision will be issued by Chancellor I'Ashea L. Myles of the Civil Trial Court in Nashville, TN. Once the award is received, BRHPC will promptly begin providing statewide services.

Lam pleased to welcome Stephen L. Demers, MBA, to BRHPC's Board of Directors. Stephen L. Demers is Chief Executive Officer of Memorial Hospital Miramar, one of six acute-care facilities of Memorial Healthcare System, a public, nonprofit hospital system nationally recognized for providing outstanding patient- and family centered care. # **Nurse-Family Partnership**

### *About the Program*

The Nurse-Family Partnership (NFP) Program works with high-risk mothers in the community. The program is aimed at improving prenatal care, decreasing infant mortality rate, and promoting breastfeeding in the community. The goal of NFP is to implement early interventions for these women. NFP strives to empower these mothers with support for the child's health and development and increase the economic sustainability of the families. Some of the qualifying events for the program include:

- Economic adversity
- Any form of high-risk behaviors
- Education levels
- Lives in Broward County in one of the following zip codes: 33311, 33313, 33319, 33023, 33024, 33025, 33060, 33064, 33069

All participants in the program are screened through a collaboration with Broward Healthy Start Coalition and its funding providers. The program has grown from just assisting first-time mothers, to now include any potentially high-risk mothers.

The NFP program is administered through a partnership between BRHPC and two hospitals in the county: **Broward Health and Holy Cross Health**. The hospitals directly employ the nurse home visitors for the program, who are trained and report to the Program Nurse Supervisor, which is employed directly through BRHPC. Broward NFP has a total of eight nursing positions; 4 nurses with Broward Health and 4 nurses with Holy Cross Health. The NFP program is funded by the Maternal Infant Early Childhood Visiting Initiative (MIECHV) which is administrated by the Florida Association of Healthy Start Coalitions.

NFP clients receive essential items monthly, such as car seats, Pack 'n Plays (for safe sleep practices), diapers, and wipes. One of the program's key goals is to help families access resources and build confidence in caring for their children.

### Visit from Congresswoman Sheila Cherfilus-McCormick's Office

On August 12, Edward Mejia, District Outreach Manager for Congresswoman Cherfilus-McCormick's office, visited BRHPC's Nurse-Family Partnership Program. The Congresswoman has a passion for community programs and initiatives, was given a firsthand look at how NFP positively impacts participants on a personal level. During the visit, current participants shared their experiences at various stages of the program, and the nurses who conduct home visits had the chance to discuss the rewarding aspects of their work. The NFP team highlighted the significant impact their efforts are making in the community.

# **Get Covered Broward**

### Recap of 2024 Open Enrollment

BRHPC, a not-for-profit organization, continues to provide enrollment assistance through a partnership with the Health Foundation of South Florida. The Get Covered Broward Program raises awareness about the availability of low-cost health insurance in Broward County through meetings, events, social media and paid media advertisements featured on Pandora, Univision Radio and various radio stations.

During the 2024 Open Enrollment Period, which ran from November 1, 2023, to January 16, 2024, the program implemented a wide range of outreach initiatives to distribute information about the toll-free number, 1-800-794-2208, and share vital details with the community. Program staff worked diligently to connect residents with essential healthcare coverage options. As a result, 1,124 Broward County residents were successfully enrolled in affordable health insurance plans.

### Special Enrollment Period

This quarter, Get Covered Broward has been raising awareness of the Special Enrollment Period (SEP), which ends on October 31st. Get Covered Broward is available to provide assistance by telephone at 1-800-794-2208 in English, Spanish, or Haitian Creole, Monday through Friday, from 8 a.m. to 5 p.m.

- You married during the SEP window.
- You become a dependent or have/adopt a child.
- You become a United States citizen or lawful permanent resident.
- You moved homes permanently.
- There was an error with your open enrollment.
- Your income is at or below 150% Federal Poverty Level (FPL).
- You have an income or circumstance change that makes you newly eligible.

### Events Participated in This Quarter

On Saturday, July 27th, Get Covered Broward participated in the **9th Annual Collier City Family Fun Day** at the Browns Community Development Center in Pompano Beach, and on Saturday, August 17th, in the **19th Annual Back-to-School & Family Fun Day** at Washington Park in Hollywood. At both events, Get Covered Broward provided education and information about the current Special Enrollment Period by distributing written materials in English and Spanish. These materials included details on eligibility criteria, how to apply for low-cost health insurance plans, and the BRHPC's toll-free Open Enrollment hotline number, 1-800-794-2208.





### Important Updates About the 2025 Open Enrollment Period

The 2025 Open Enrollment Period begins on November 1, 2024, and ends on January 15, 2025. Get Covered Broward is dedicated to helping consumers understand their coverage options and answering any questions related to plan selection. Whether you are currently uninsured or seeking more affordable health coverage, this Open Enrollment Period is your opportunity. Call 1-800-794-2208 for assistance in English, Spanish, or Haitian Creole.

- November 1, 2024: Open Enrollment starts. This is the first day you can enroll in, renew or change health plans through the Marketplace for the upcoming year.
   Coverage will start as soon as January 1, 2025.
- **December 15, 2024:** This is the last day to enroll in or change plans for coverage to start January 1, 2025.
- January 1, 2025: Coverage starts for those who enroll in or change plans by December 15, 2024, and pay their first premium.
- January 15, 2025: Open Enrollment ends. This is the last day to enroll in or change Marketplace health plans for the year. After this date, you can enroll in or change plans only if you qualify for a Special Enrollment Period.
- **February 1, 2025:** Coverage starts for those who enrolled in or changed plans between December 16, 2024, through January 15, 2025, and pay their first premium.

# **Centralized Intake and Eligibility Determination**

About the Program

Centralized Intake & Eligibility Determination's (CIED) core functions include determining eligibility for Ryan White Part A services and/or third-party payers. CIED also provides information and referrals to services for clients who are seeking medical and supportive services. CIED Services include a centralized intake, eligibility, enrollment, and information/referral process for all Ryan White Part A funded services. CIED continues to serve as the single point of entry for Persons Living with HIV and AIDS (PLWHA) who are residents of Broward County.

An integral part of the success of CIED is the unshakeable dedication and passion to serve the HIV community along with the various Ryan White Networks of collaborative organizations, community partners and clients. Clients consistently comment about the professionalism, supportive referrals, and compassionate engagements they experienced and expressed their genuine appreciation for the services rendered and accommodations made by some of the most exceptionally caring and client-focused staff.



CIED staff have embarked on a new Quality Improvement Project for 2024 /2025. Our goal involves actively engaging clients to better understand the journey to viral load suppression and those complicated factors and barriers that impact adherence to treatment over a three-month period. CIED team welcomes **Barbara France**, Administrative Assistant, who brings a wealth of knowledge, outstanding customer service, and support experience; diverse cultural; and multi-lingual skills to our team effort. CIED looks forward to the outstanding contributions and dedication she will provide to strengthen our capacity to better serve individuals and families throughout Broward County.

We encourage all Ryan White Part A clients to actively engage with CIED staff, case managers, and providers of medical and supportive care services as we all unite and prepare for the Affordable Care Act (ACA) Marketplace Open enrollment period in November 2024. Eligible clients are urged to prepare early and engage with the American Exchange, IBM, a contracted entity that can assist clients eligible for ADAP-approved premium assistance and insurance support services. This Fall, CIED team members welcome fresh ideas and new intervention strategies to better engage our clients for exceptional experiences. Clients are requested to review their rights and responsibilities; to improve and ensure adherence to eligibility guidelines; and to prepare effectively to experience seamless access to medical and supportive services. We encourage clients to join special focus group sessions and relay the client's perspective on ways to engage, ensure and streamline processes that comply with Ryan White guidelines and policies for implementation.

# **Housing Opportunities For Persons with HIV/AIDS**

### *About the Program*

The Housing Assistance Program at Broward Regional Health Planning Council, Inc., provides services to the community under the Housing Opportunities for Persons with HIV/AIDS (HOPWA) program. For the last fifteen years, the team has been working to assist eligible low-income [Area Median Income 80% or below] Broward County residents with past due rent, utility, mortgage assistance, and permanent housing placement.

From October 2023 to July 2024, the Housing Assistance program BRHPC provided over 263 unduplicated clients with over \$523,398.21 for short-term rental, permanent housing placement, utility, mortgage, and emergency hotel voucher assistance to help prevent homelessness.

BRHPC has been working closely with the local HOPWA Grantee and the City of Fort Lauderdale's Housing and Community Development Division to find better ways to deliver services to the community. BRHPC has also cooperated with local HOPWA agencies such as Care Resource, Mount Olive Development Corporation (MODCO), and SunServe to offer training, technical assistance, and service coordination.

### Client Success Story



We are pleased to share that, thanks to the STRMU assistance provided to one of our clients, a settlement agreement has successfully resolved their eviction case. As a result, our client is able to remain safely housed, with no further risk to their housing security. We are proud that our collaborative efforts continue to make a positive impact on individuals living with HIV/AIDS.

As we enter the fourth quarter of the current fiscal year, the HOPWA team is looking forward to another successful year in helping persons living with HIV/AIDS in our community to prevent and end homelessness.

# **Tenant Based Rental Voucher Program**

About the Program

Tenant Base Rental Voucher (TBRV) program provides low-income HIV/AIDS persons or families rental assistance to live in private, independent apartment units. The TBRV case managers continues to assist the client if they move to another rental property in Broward County. TBRV subsidy levels vary case by case where the program considers the entire household income, the unit size, and the Fair Market Rent (FMR) standards. Once these factors are considered, the program covers a portion of the client's rent, with the client responsible for paying the remainder.

The HOPWA department is pleased to welcome two new housing case managers, **Tatyana Roundtree** and **Tiffani Pierson**. Tatyana joins us from the Supportive Services for Veterans and Families (SSVF) program, bringing a strong administrative background and a commitment to expanding her skills and supporting others. Tiffani Pierson returns to the housing industry with experience in client services and a passion for connecting clients with the resources needed to maintain safe, decent, and affordable housing. We are confident that both Tatyana and Tiffani will make valuable contributions to our team.

TBRV partners with Consolidated Credit to offer clients financial literacy, budgeting, homeownership, and credit repair counseling. Monthly schedules from Consolidated Credit provide information on upcoming online and in-person seminars available in English and Spanish, which have been met with enthusiasm by our clients.

**New Enrollment:** The TBRV program continues to work toward its goals by enrolling new clients. Clients are selected from the City of Fort Lauderdale waitlist through a lottery system. All incoming clients must meet the U.S. Department of Housing and Urban Development income guidelines and HOPWA eligibility criteria.

### The 2024 National Ryan White Conference

This event served as a vital platform for sharing innovative strategies and best practices aimed at improving health outcomes for people living with HIV. Attendees included representatives from HIV Health Services Planning Councils, clinical quality management teams, and community partners. Through a series of presentations, workshops, and collaborative sessions, participants engaged in productive discussions about the future of HIV care, focusing on optimizing service delivery, enhancing patient outcomes, and addressing healthcare disparities. The conference underscored the need for continuous improvement and the importance of data-driven strategies in advancing HIV care.

The Broward County Human Services Community Partnerships Division team, including Jessica Roy, Administrator, Arnold Mahoney, Glenroy James, and Timothy Thompson, was also in attendance. Their presence further strengthened the collaborative efforts between the HIV Health Services Planning Council (HIVPC) and the Human Services Division, underscoring their shared commitment to improving HIV care and services in Broward County.

Danielle, Debbie, and Timothy presented "Continuous Clinical Quality Improvement Program Elevated by Broward Ryan White Part A EMA Using Novel Quality Improvement Toolkit," showcasing a Quality Improvement (QI) Toolkit developed in 2020 by BRHPC's CQM Health Planners and the Clinical Consultant. Designed to support subrecipients of Broward County's Ryan White Part A grant, the QI Toolkit provides a structured template for QI Network members to systematically review and analyze quantitative and qualitative data related to program and client care needs. This approach helps members develop focused AIM statements and implement improvement cycles that positively impact clients' health outcomes throughout the county.

A key feature of the QI Toolkit is its adaptability. It is continuously evaluated and updated in real-time and annually to serve the QI Network members better. These updates ensure that the Toolkit remains effective for guiding quality improvement processes, particularly in services for people living with HIV in Broward County. The presentation, along with the ensuing discussions, emphasized the significant positive impact the Toolkit has had since its inception and its ongoing role in enhancing clinical quality improvement efforts across the EMA. The insights the CQM team shared were well-received, highlighting their leadership in continuously developing innovative tools to improve HIV care and services.

# **Insurance Benefits Management Program**



BRHPC's current enrollment in the Premium Assistance program has achieved a new record high of almost 9,500 clients, due in part to the lowered Federal Poverty Level (FPL) instituted by the program.

BRHPC will be launching our annual Pre-Registration page on our <a href="Enroll.BRHPC.org">Enroll.BRHPC.org</a> site for the 2025 Open Enrollment Period starting October 1st, 2024, which will remain available throughout the month of October. The Pre-Registration page is geared towards those clients who like the plan they currently have and would like to remain in the same plan for the upcoming new year. This offers the client peace of mind knowing that their election for 2025 has been completed and payment will be made well in advance, thus ensuring their benefits remain active from one plan year to the next. Utilizing this page means they don't need to wait until the start of Open Enrollment on November 1st, 2024. This feature is flexible and does not obligate the client to that specific plan, should the client change their mind. We simply ask they visit the <a href="Enroll.BRHPC.org">Enroll.BRHPC.org</a> site to inform us of their plan selection so we can have the most current information ensuring prompt updating of their record, accurate payment and effectuation of the policy.

Participants MUST Enroll in Premium Assistance Annually. Enroll online at https://enroll.brhpc.org.over the telephone by calling 1-844-441-4422 or calling your County Health Department. This is REQUIRED even if you enrolled with an agent/broker, navigator, case manage, etc.

Enrollment and reenrollment in the premium assistance program is required prior to each calendar year regardless of the type of insurance enrolled in, including marketplace/Affordable Care Act (ACA), employer sponsored insurance, or COBRA.

Insurance Enrollment Assistance is provided by our partner American Exchange

The <u>Enroll.BRHPC.org</u> site has a fresh look new for Open Enrollment 2025. Utilizing a decision tree design and by answering a few questions in the beginning, this approach will ensure the client is using the correct form and prevent feeling of being overwhelmed with too much information at one time. It should only take about 10 minutes to complete, leaving plenty of time to enjoy the holiday season.

# **Support Services for Veterans and Families**

### About the Program

Broward Regional Health Planning Council is funded by a grant between the Advocate Program, Inc., and the US Department of Veterans Affairs to provide supportive services to veterans. The Support Services for Veterans and Families (SSVF) program has a primary goal of rapid re-housing for Veterans and their families.

BRHPC provides case managers to coordinate SSVF case management and rapid rehousing efforts for veterans and their families. Case Managers (CM) also assist SSVF participants in transitioning from homelessness to permanent, stable housing arrangements or supported housing arrangements.



BRHPC SSVF case managers serve as the primary point of contact in the coordination of services, on behalf of the clients. They are responsible for the referral and follow up with local community service providers, as well as fellow SSVF partner agencies working in concert to assist with the successful housing outcomes for the program participants.

## New SSVF Broward Office

In the past, the Advocate Program only had offices in Dade County and wanted to transition the SSVF Program into Broward County. On May 1, 2022, BRHPC entered into a contract with Advocate Program Inc. to provide case management services in Broward County. With BRHPC's support, the Advocate Program successfully transitioned into Broward County, establishing an office in Wilton Manors. The Advocate Program is fully integrated in Broward County, and therefore, there is no need to continue the contract with BRHPC for the 2024 to 2025 contract year. We were happy to be able to facilitate the successful and smooth transition of the Advocate Program in Broward County and we remain committed to supporting the SSVF Program as needed.

# **Health Insurance Continuation Program**



Program Overview




The Health Insurance Continuation Program (HICP) is a phenomenal program offered through Broward Regional Health Planning Council. The program is designed to ensure continuity of quality health care for clients that are HIV positive. The program provides funding for primary care services and assists clients that do not have sufficient health care coverage or financial resources to manage treatment for

HIV/AIDS. Ryan White Part A funding is used to provide coverage for medical services and copayments for prescriptions. The Ryan White Part A program provides assistance for clients that reside in Broward County.

HICP provides both client and provider orientation and education regarding the program's rules, processes, timelines, and limitations of the program. Taking this opportunity to explain the complexity of the program has maximized the process of assisting the clients to its fullest. The clients have been able to explain the program like never before to new providers with the hope they are willing to accept third-party payments from HICP. This allows for the clients' right to choose who they receive services from and prevents disruptions with access to care.

Additionally, previous providers that stopped accepting payments from HICP, due to a procedural change that was implemented March 1st, 2023, are now willing to accept payments from the program again. All of this allows for the clients to expand their available healthcare providers in-network through their health insurance plan. HICP continues to refine and implement best practices for the program to best serve the Broward county clients enrolled in HICP.

Level II Background Screenings Available at BRHPC

BRHPC offers Live Scan fingerprinting technology for Level II Background Screening for the Department of Children and Families (DCF), Agency for Health Care Administration (AHCA), Volunteer and Employee Criminal History System (VECHS), Elder Affairs, and the Department of Business and Professional Regulation (DBPR).



Level II background checks provide a comprehensive view of an individual's background, including a thorough examination of criminal history. This deeper scrutiny reduces risks, ensures legal compliance, and instills confidence in decision-making, making them valuable for roles and situations where accuracy and security are paramount. Whether it's for employment, professional licensing, or other essential needs, our Live Scan Services adhere to the highest industry standards, offering you fast, secure and thorough results.

Live Scan allows for electronic submission of fingerprint screens, with results within 24 to 48 hours. Additional

services such as photo submission to the AHCA clearinghouse are available at BRHPC. In order to assist community agencies and providers in meeting legislative requirements of HB 7069, BRHPC acquired equipment with the capability to scan fingerprints electronically for Level II Background Screening, using Live Scan technology.

BRHPC's fingerprinting clientele include hospital employees, guardian ad litem programs, doctors' offices, non-profit and social service agencies, colleges, universities and more. Fingerprinting clients must bring a valid ID and the identifying number for the organization requesting fingerprints (ORI, OCA).

Social media plays a crucial role in disseminating information, and BRHPC maintains an active presence on Facebook, X (formerly Twitter), LinkedIn, and Instagram. These campaigns not only raise awareness of vital public health issues but also promote BRHPC's programs and services, increase the organization's visibility at national, state, and local levels, and drive traffic to the BRHPC website.

### Florida Public Health Annual Conference



**Dr. Claudia Serna**, along with **Nicole Cohen** and NSU intern **Daniella Martinez**, submitted an abstract to the 2024 Florida Public Health Association Annual Conference highlighting their social media campaign, "Educating Individuals on the Importance of Influenza Prevention." The abstract was accepted and presented during the poster session on July 20th. The campaign featured five posts shared on the following platforms

(Left to Right) Nicole Cohen & Daniella Martinez Instagram, LinkedIn, and X—covering flu symptoms and prevention tips, reaching a combined total of 585 individuals. Additionally, the same five posts were boosted on Facebook, significantly extending their reach to 15,759 individuals. The campaign had a total expenditure of \$623.84, demonstrating the effectiveness of Facebook advertising in reaching a larger audience.

### New NSU Intern Spotlight



Meghana Jagarlamudi is a senior Public Health major at Nova Southeastern University, with minors in Research Studies, Prehealth, Biology, and Honors Transdisciplinary Studies. A total of two free posts were shared on the following platforms Instagram, LinkedIn and X reaching a total of 442 individuals. The same two posts were boosted on Facebook reaching 3,916 individuals.









# Florida Health Data Warehouse

About the Systems

BRHPC's long-term strategy for expanding its Health Data Warehouse offers hospitals and healthcare systems the unique opportunity to be at the forefront of data-driven decision-making, comparing hospitals and procedures across specific counties and the entire State of Florida. The Health Data Warehouse is a collection of health information databases developed by BRHPC which are designed to assist hospital and nursing home administrators in their strategic planning & decision-making endeavors. These databases offer a wide array of health-oriented data sets, including Hospital & Nursing Home utilization, health indicators & Emergency Department data, and Diagnosis-Related Groups (DRGs) data, as well as the financial and demographic databases.

The **Medical Facilities Utilization Reporting System** improves upon a manual reporting system that BRHPC continues to administer for over 40 years. These data sets are accessible online, improving program efficiency and overall functionality, giving users the ability to utilize data to make capacity and quality-related decisions. The database has the ability to generate 39 exportable and/or ready to print reports, having been expanded to become a strategic planning tool for administrators to review and assess variances in utilization. The datasets in the Data Warehouse provide Healthcare Practitioners, Planners, Researchers and Policy-makers with a vulnerable community-planning tool to target initiatives, set benchmarks to increase healthcare access and quality, identify target areas for quality improvement, establish healthcare system delivery policies and develop programs to address identified needs.
